On April 1, 2020, the bids for the “City of Granjeno 2019 Public Facilities & Improvement Project” were opened. Six (6) companies submitted bids for this project. The companies and their total prices are as follow:


NM Contracting, LLC	\$1,200,500.00

This project has a total budget of \$1,033,965.97 which \$110,387.11 was dedicated for engineering fees, testing fees and advertisement fees. A remainder of \$923,578.86 is for construction funding.

The lowest bid of \$1,200,500 submitted by NM Contracting exceeded the allowable construction funding by \$276,921.14.

Based on the lowest bidder amount exceeding the allowable construction funding, we are recommending to reject all bids until funding is available.
