Re: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for May 12, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Regular Agenda Item 6.C. (AI-75492) – Human Resources for Fire Marshal
Pursuant to the Fiscal Note, funding for the change in classification is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 9.A.1 (AI-75500) – Purchasing Department
Pursuant to the Fiscal Impact, the construction of the new laboratory will be funded from the CARES Act Fund. The agenda item did not disclose the justification for funding the project with the CARES Act Fund. In addition, the guidance from the Treasury Department specifically includes expenses of establishing temporary public medical facilities, including construction costs, as eligible expenditures. However, this project is for a permanent facility that will likely not be operational prior to December 30, 2020. We have requested legal counsel's assistance in determining whether expenditures incurred for this project would be allowable under the CARES Act. Also, the scoring grid is not attached. We recommend that: (1) the justification be disclosed on the Background section; (2) legal counsel's and/or U.S. Treasury Department's opinion be obtained; and (3) the scoring grid be attached to Agenda Quick prior to Commissioners Court approval.

Regular Agenda Item 9.A.2 (AI-75502) – Purchasing Department
Pursuant to the Fiscal Impact, the purchase of the six generators will be funded from the CARES Act Fund. The agenda item did not disclose the justification for funding the purchase with the CARES Act Fund. In addition, the scoring grid is not attached. We recommend that: (1) the justification be disclosed on the Background section; and (2) the scoring grid be attached to Agenda Quick prior to Commissioners Court approval.

Regular Agenda Item 9.A.3 (AI-75499) – Purchasing Department

Regular Agenda Item 9.A.4 (AI-75480) – Purchasing Department

Regular Agenda Item 9.E.1 (AI-75497) – Purchasing Department for Health & Human Services
The funding source for this item was not disclosed in the Fiscal Impact section. However, other agenda items related to the construction of a new laboratory indicate that funding will come from the CARES Act Fund. Therefore, please see the observation for item 9.A.1 (AI-75500) above.
