Good afternoon and hope you're doing well and healthy during these difficult times. I'm reaching out first and foremost to say hello and wish you well.

We're currently engaged in the process of transitioning to Phase 2 of this much needed MPO TxDOT Off System project for both local governments. Unfortunately in doing so we've identified new fees by TxDOT and require us to amend the original agreement as noted below.

The change is in the amount of \$261K or as noted on correspondence. This amount is evenly split by both local governments increasing participation by \$130,500.00 for each party. The draft agreement has been prepared by our consultant for your review. Please feel free to comment on drafted agreements and propose recommendations if any.
