Mr. Vina,

Good Morning and hope all is well with you. I was hoping to make contact in hopes to have your assistance with an ICA between hidalgo county pct 1 and the city of weslaco for an overlay road construction project.

Mile 5 is an interconnecting county road that runs in and out of the city of Weslaco and Hidalgo County limits. The city has expressed interest in collaborating with Hidalgo County on this project by paying for the material. Project limits start on Border Avenue and go west for approximately 3,964 lft. The road varies in width from the 22-38 ft of paved sections and will be paved using our standard protocol of 2 inches for asphalt. Total material cost for the city of Weslaco is in the amount of \$95,793.00.

The language must state that weslaco will pay the material cost upon approval of agreement with at least 180 days for completion.

We're hoping to Present this to the city of Weslaco for their consideration at next Tuesday's city meeting. Please feel free to call me to discuss further at 956-332-7282.
