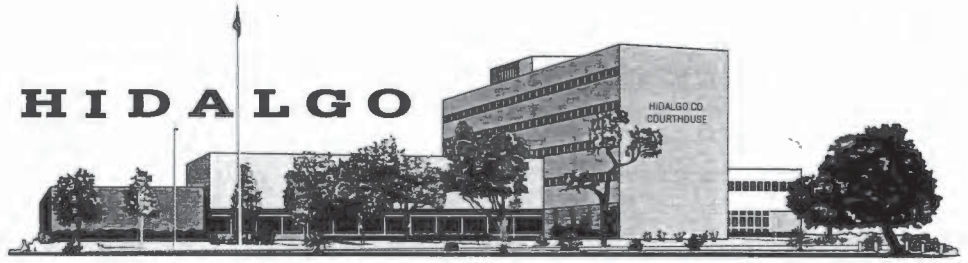

RE: Request for Change Fund Increase for Edinburg and Alamo Motor Vehicle Substations

Dear Mr. Villarreal:

We reviewed your written request for an increase of the Edinburg and Alamo Motor Vehicle Substations change funds in the amount of \$1,800.00 and \$1,500.00, respectively:

According to Local Government Code Section 130.902, "The Commissioners Court of a county may set aside from the general fund of the county an amount approved by the County Auditor for use as a change fund by any county or district official who collects public funds. The fund may be used only to make change in connection with collections that are due and payable to the county, state, or another political subdivision of the state that are made by the official. On the recommendation of the county auditor, the Commissioners Court may increase or decrease the change fund at any time."

Please submit this letter to Commissioners Court requesting approval to increase the change funds for the Edinburg and Alamo Motor Vehicle Substations in the amount of \$1,800.00 and \$1,500.00, respectively. Once Commissioners Court approval is obtained, please request a check from the Hidalgo County Auditor's Office to be made payable to "Pablo "Paul" Villarreal, Jr. Hidalgo County Tax Assessor/Collector."

You will be responsible for the change funds. The change funds should be accounted for on a daily basis and safeguarded under lock and key. Please be reminded that the change funds are not to serve as petty cash or comingled with personal funds.
