WORK AUTHORIZATION NO. 03

THIS WORK AUTHORIZATION is made pursuant to and in accordance with the terms and conditions of the Agreement between Hidalgo County, Texas ("County" or "Owner") and Terracon Consultants, Inc., a Delaware Corporation ("Laboratory"). Dated September 25, 2018 ("Agreement") for the Hidalgo County Courthouse Project ("Project").

PART 1. WORK DESCRIPTION

The purpose of this Work Authorization is for the Laboratory to provide under the Agreement Services, generally described as follows:

Provide additional Curtainwall Consulting Services to perform the following tasks:

Task 1: Perform periodic site visits to the project site observe and document the installation of curtainwall systems. The anticipated number of required visits are three (3).

Task 2: Conduct a site visit to the offices of Dynamic Glass to observe and document the assembly of the curtainwall mock-up. The anticipated number of visits to perform this task is one (1).

Task 3: Perform site visits to the offices of Dynamic Glass to observe adhesion pull testing and/or Mock-up testing. The anticipated number of required visits are three (3).

Task 4: Conduct visits to Dynamic Glass offices to observe and document fabrication/production of curtainwall units. The anticipated number of days to perform this task is five (5).

Task 5: Perform a two-dimensional (2D) Light Detection and Ranging (LiDAR) scan of the exterior wall surfaces of the courthouse to assess the condition of the exterior elevations. Terracon will engage Carrizales Land Surveying (CLS) of Edinburg, Texas as its sub-consultant to perform this task.

Task 6: Analyze the LiDAR scan data to assess the position of the position of the exposed concrete framing relative to the curtainwall assemblies.

PART 2. PRICE

The estimated not to exceed fee for all Services under this Work Authorization is \$ 62,570.00 ("Price"). A breakdown for each task and the anticipated number of visits is provided below.
