We conducted a limited scope review of the Regular and Consent Agendas for May 26, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 6.D. (AI-75621) – Membership Dues/Certification: District Attorney's Office

The Affidavit for Membership Dues for Rosa I. Martinez is not attached. We recommend that the affidavit be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 8.C. (AI-75632) – Human Resources for Public Defender

Pursuant to the Fiscal Note, funding for the auto allowance is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 14.A. (AI-75681) – Budget & Management

The Memorandum of Understanding (MOU) and legal counsel's review and approval of the MOU is not attached. We recommend that the MOU and legal counsel's approval be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 15.A. (AI-75676) – Purchasing Department

Legal counsels review and approval of the engagement letter is not attached. We recommend legal counsel's approval be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 15.C.3 (AI-75683) – Purchasing Department for Precinct No. 2
