**AMENDMENT AND RENEWAL OF SERVICE CONTRACT**  
**(C-15-098-06-02)**

This **AMENDMENT AND RENEWAL** of the service contract for “**Housing and Confinement of Inmates**” for **Hidalgo County** in connection to contract #**C-15-098-06-02**, dated June 17, 2015, by and between **HIDALGO COUNTY, TEXAS** (“County”) and **Geo Group, Inc** (“Company”), collectively referred to as (“Parties”) is entered into between the Parties effective this **26** day of **May, 2020**.

**WHEREAS**, Company and County entered into a Contract dated **June 17, 2015**, in which Company agreed to provide certain services for the purpose of “**Housing and Confinement of Inmates**” for **Hidalgo County** (the “Contract”);

**WHEREAS**, Section 4.03, of the Contract, entitled Per Diem Rate, states, “the per diem rate for the actual housing and care of County inmates on “an as needed basis” and related detention and transportation services specified in this Agreement is fifty four dollars (\$54.00) per inmate per day.”

**WHEREAS**, the parties agree a five dollar (\$5.00) per inmate, per day increase from the original agreed fifty four dollars (\$54.00) per inmate per day, derived from a standard cost of living rate (CPI) of two percent (2%) for each of the past five years is warranted;

**WHEREAS**, the parties desire to amend the Contract to increase the per diem rate of actual housing and care of County inmates, and related detention and transportation services, and

**WHEREAS**, the County also wishes to exercise its option for annual renewal of the contract.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following:

1. The Contract is hereby amended so that, The Per Diem Rate reflected in section 4.03 of the Contract is amended to reflect the new agreed Per Diem rate of:

**Fifty Nine Dollars (\$59.00) per inmate, per day.**

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms and provisions of the Contract as amended;

2. Additionally, as per the agreement and at its sole discretion, the County hereby renews this contract for an additional one (1) year term beginning June 17, 2020 and expiring June 16, 2021.
