Consent Agenda Item 9.F. (AI-76012) – Purchasing Department

The contract number on the agenda caption should be C-19-059-07-16. We recommend that the correct contract number be stated for the record prior to Commissioners Court approval.

Regular Agenda Item 6.A. (AI-76065) – County Judge's Office

Legal counsel's final review and approval of the VIDA agreement is not attached. We recommend that legal counsel's final approval be attached prior to Commissioners Court approval.

Regular Agenda Item 8.B. (AI-76090) – Human Resources for Elections

Pursuant to the Fiscal Note, funding to extend the temporary positions is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 8.E. (AI-76120) – Human Resources for 275th District Court

Pursuant to the Fiscal Note, funding to extend the temporary position is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 8.G. (AI-76070) – Human Resources for Justice of the Peace Pct. 3 / Place 2

Pursuant to the Fiscal Note, funding for the temporary position is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 12.A. (AI-76094) – IT Department

Funding for the Pct. 4 data plan services is not in place. We recommend that the requisition to fund the new data plan services be disclosed in the Fiscal Impact section prior to Commissioners Court approval.
