Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for June 30, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

**Consent Agenda Item 6.A. (AI-76181) – Tax Refunds**

The amount of the tax refund for account number W2300.99.000.0000.Z7 should be \$4,779.30. We recommend that the correct tax refund amount be stated for the record prior to Commissioners Court approval.

**Regular Agenda Item 16.A.4 (AI-76204) – Purchasing Department**

The Certificates of Interested Parties (Form 1295) for the Pro Health Staffing and AHS Staffing, LLC are not attached. We recommend that the Forms be attached prior to Commissioners Court approval.

**Regular Agenda Item 16.B. (AI-76207) – Purchasing Department for County Judge's Office**

The repairs/renovations to two buildings for use as an EOC and call center will be funded through the Coronavirus Relief Fund. The timeframe for the project is not disclosed in the background or agenda item briefing. We recommend that the timeframe for completion of the project be disclosed on the background section of the agenda item. If completion of the project is not anticipated before December 30, 2020, we recommend that an alternate source of funding be identified for the project.

**Regular Agenda Item 16.C.1 (AI-76228) – Purchasing Department for Precinct No. 3**

The amount for the purchase of 2 roll off trucks is \$308,116.80 and not as stated on the agenda caption. We recommend that the correct amount be stated for the record prior to Commissioners Court approval.

**Regular Agenda Item 16.F.2 (AI-75841) – Purchasing Department for Health & Human Services Dept.**

The agenda caption does not include a request for Commissioners Court to approve the Netsmart quote, Master Agreement, or Mutual Non-Disclosure Agreement. We recommend that a request for Commissioners Court approval of these documents be placed on the next agenda.
