Counselors:

On the HCCC meeting of 05-05-20 two ILAs were placed for action. One ILA was between HC/SO and the City of Progreso. It was placed directly by the SO. The item was approved. However, the SO would like to amend and remove provisions b. and f. since both require that the vehicles belong to the county during the term of the ILA and thereafter when no longer needed by the City be returned to the HC/SO. The SO does not want to track the vehicles nor keep it in their inventory list. They simply want to transfer it permanently to the City of Progreso. It appears that the provisions are part of the agreement since the third WHEREAS states that the equipment is being "shared". The SO has additional equipment that they wish to transfer to the City of Progreso.

On the same CC meeting, the Purchasing Dept. placed another ILA between HC/SO and the City of Alton. That form of ILA was approved by your legal civil section. The SO has additional equipment they wish to transfer to the City of Alton. We will draft another ILA using the same draft format for the transfer of additional equipment.

QUESTION/OPTIONS:

1. Do we rescind action on the first ILA and replace with a version used for the City of Alton which will include additional equipment [along with the two vehicles originally transferred] The rescission would allow Purchasing to correct the omission of declaring the vehicles "surplus" as this was not part of the SO agenda item. **OR,**

2. Do we just draft an Amended ILA to remove the word sharing and provisions b. & f. and include the new equipment that the SO wants to transfer?

Please advise on your thoughts or alternative recommendations.
