As requested, this office reviewed LRGVDC's requests regarding the San Carlos Bus Shelter MOU. From my conversations with Ms. Reyes and yourself, I understand that the Precinct approves the addition for the Precinct to pick-up and assemble the bus shelter.

As to the insurance provision, Ms. Reyes sent LRGVDC's response indicating: "*Item 4 and 5: We are not currently insuring bus shelters, we ask our partners to take over this responsibility.*" We previously recommended that the County should insure the item as well as LRGVDC since they retain ownership of the item. Please advise if the Precinct wants to proceed as requested with the County only providing insurance.
