Hello Mr. Vina,

In order to continue to best serve our taxpayers and whereas, public convenience will be furthered, Mr. Villarreal would like to request legal approval for a limited service deputy contract with Lone Star National Bank. Lone Star National Bank would like the opportunity to act as an agent for the Hidalgo County Tax Collector in the issuance of motor vehicle registration renewal stickers. The company has provided our office with a signed limited service deputy agreement. Attached is Exhibit "A" which lists the six (6) locations under consideration.

Discussion and approval to execute an agreement between the County of Hidalgo and Lone Star National Bank to act as a limited-service deputy authorized agent of the County in the issuance of Motor Vehicle Registration Renewal Stickers. This agreement is subject to the Limited Service Deputy providing surety bonds in the amount of \$5,000 per location listed on Exhibit A and final legal review.

Background:

Lone Star National Bank applied to be an authorized limited service deputy for Hidalgo County. The Tax Assessor-Collector sees a need to offer additional locations to the citizens of Hidalgo County. LSNB will guarantee faithful performance of duties by posting surety bonds in the amount of \$5,000 per location. LSNB has also agreed to comply with the requirements of the TxDMV WebAgent system. The statute to the Transportation Code and Texas Administrative Code that allow for this agreement are included.
