Be advised, that in order to proceed with the County's option to extend/renew its **60 days grace period option and will be in effect until October 14, 2020 under the same rates, terms and conditions as provided in the current contract with Rio Grande Hauling LLC, or until the new contract gets awarded** for the referenced project, the County is required, as of **January 1, 2016**, to comply with the **Texas Government Code, §2252.908**, and the rules issued by the **Texas Ethics Commission** found in Title 1, Section 46.1, 46.3 and 46.5 of the Texas Administrative Code. In accordance with these **requirements for the type of contract being** considered, a business must submit a completed **Certificate of Interested Parties Form 1295**, to the County before the County may enter into a contract with the business entity.

In order to proceed with approval of **60 days Extension** for referenced project by **Commissioners Court on July 21, 2020**, the signed "**HB Form 1295**" and "**Extension Notice**" must be received in our office completed **by no later than Thursday, July 09, 2020 or sooner if possible**. Hidalgo County cannot enter into a contract until Form 1295 is submitted, therefore, failure to timely submit Form 1295 signed, may result in delay of award.

In, addition, please include your "**Updated Certificate of Insurance**" with acknowledgment of receipt to this notice by signing below and returning to the Hidalgo County Purchasing Department, via email: elena.gomez@co.hidalgo.tx.us by no later than date reflected **above**.


