Regular Agenda Item 10.A. (AI-76485) – Community Service Agency

The amended eligibility guidelines are not attached. We recommend that the amended eligibility guidelines be attached prior to Commissioners Court approval.

Regular Agenda Item 14.C.1. (AI-76488) – Purchasing Department

The correct firm name should be RO Engineering, PLLC. We recommend that the correct firm name be stated for the record prior to Commissioners Court approval.

Regular Agenda Item 16.A.1.a. – Executive Office

The interlocal cooperation agreement with UTRGV and legal counsel's review and approval of the agreement are not attached. We recommend that the agreement and legal counsel's approval be attached prior to Commissioners Court approval.
