Be advised, that County has chosen the option to exercise the sixty (60) day extension (under same rates, terms and conditions) with **Arguindegui Management Co., LLC dba/Arguindegui Oil Co., II LTD** for the referenced project. However, in order to proceed with approval of the extension, the County is required, as of **January 1, 2016**, to comply with the **Texas Government Code, §2252.908**, and the rules issued by the **Texas Ethics Commission** found in Title 1, Section 46.1, 46.3 and 46.5 of the Texas Administrative Code. In accordance with these requirements for the type of contract being considered, a business must submit a completed **Certificate of Interested Parties Form 1295**, to the County before the County may enter into a contract with the business entity.

In order to proceed with approval of **60 Day Extension** for referenced project by **Commissioners Court on July 28, 2020**, the signed "**HB Form 1295**" and "**Extension Notice**" must be received in our office completed **by no later than Wednesday, July 23, 2020 or sooner if possible**. Hidalgo County cannot enter into a contract until Form 1295 is submitted, therefore, failure to timely submit signed Form 1295 may result in delay of award.
