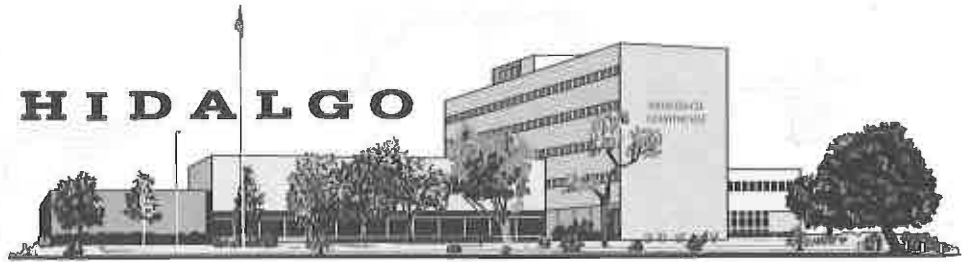

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for July 28, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 12.G. (AI-76610) – Purchasing Department

The Certificate of Interested Parties (Form 1295) for Texas Cordia Construction, LLC is not attached. We recommend that Form 1295 be attached prior to Commissioners Court approval.

Regular Agenda Item 10.C. (AI-76468) – Human Resources

The agenda item briefing for the two (2) Forensic Center Attendant positions was not attached. We recommend that the agenda item briefing for the two (2) Forensic Center Attendant positions be attached prior to Commissioners Court approval.

Regular Agenda Item 17.C. (AI-76611) – Budget & Management

Legal counsel's review and approval of the agreement is not attached. In addition, funding for the fees associated with the agreement was not identified. We recommend that legal counsel's approval be attached and funding be identified prior to Commissioners Court approval.

Regular Agenda Item 18.A.1. (AI-76612) – Purchasing Department

The Certificate of Interested Parties (Form 1295) for Elite Transport and Clean-up Services is not attached. We recommend that Form 1295 be attached prior to Commissioners Court approval.

Regular Agenda Item 18.A.2. (AI-76592) – Purchasing Department

Commissioners Court previously approved to fund the Bio-Safety Lab from General Fund (see minutes for AI-75885 on 6/9/2020) due to a question on the use of Coronavirus Relief Funds (CRF) for this project. The Fiscal Impact for this agenda item indicates that the CRF will be used to fund the "soft costs" for the project; however, legal counsel's opinion on the use of CRF for this project is not attached. We recommend that legal counsel's opinion related to the use of CRF for this project be attached prior to Commissioners Court approval.
