Good morning Ms. Salinas,

Our office reviewed the consulting agreement between the County of Hidalgo and Absolute Business Consulting Group, LLC. At this time our office approves as to form of the agreement subject to the following recommendations:

1. At Paragraph 3, replace with the following:

As Consideration for the services to be rendered by the Consultant, as identified in Exhibit "A," attached hereto, County agrees to pay Consultant the fees as outlined in Exhibit "B" Fee Schedule, which is attached to and made a part of this contract for Public Relations and Communications Consulting. Payments to the Consultant for Services shall be payable against written invoice submitted by Consultant in accordance with the Texas Prompt Payment Act, Tex. Govt. Code Ch. 2251.

2. At Paragraph 22, we recommend **bolding** the paragraph as indemnity provisions must be clear and conspicuous in order to be enforceable.

3. At Paragraph 1, we recommend changing "APPENDIX" to "EXHIBIT," to keep uniformity throughout contract.

4. At Paragraph 24 (4), we recommend changing APPENDIX "B" to "EXHIBIT "C"
