Good Morning Ms. Salazar,

As requested this office reviewed the agreement for security guard services (C-20-059-07-28) and the scope of services provided by vendor MLG in comparison to the scope of services provided in County's RFP w/Q. We recommend including it as additional obligations to perform. As such, the agreement is approved it as to form subject to the following recommended modification:

- Revise paragraph No. 2 on p. 1 as follows:

2. Company hereby promises and agrees to render and provide, during the term of this Contract, and shall be obligated to render and provide the Services in accordance with the Specifications contained in Exhibit "A" Request for Sealed Proposals **with Qualifications** (RFP w/Q) Procurement Packet and **Exhibit A-1-Scope of Services provided by MLG** within Hidalgo County following a request for Services by the County of Hidalgo. **The specifications indicated in Exhibit A-1 are incorporated herein for all purposes and are in addition to those in Exhibit A. Any conflict between the terms indicated in Exhibit A and Exhibit A-1 shall be held in favor of the more restrictive term.** Company agrees in performing the Services that it will use proper professional standards, comply with any and all appropriate laws and regulations in providing the Services, and devote such time as is necessary to safely and efficiently provide the Services. Further Hidalgo County reserves the right to request these services from other sources other than the successful vendor and shall not be in violation of any terms or conditions of said contract.

- additionally we recommend the following minor modifications for clarification:

- 3rd "Whereas" paragraph: add the language in blue to: Exhibit "A" Request for Sealed Proposals with/Qualifications (RFP w/ Q)

- Add to the end of number 6 of the agreement: **in accordance with the Texas Prompt Payment Act, Tex. Govt. Code Ch. 2251.**
