**Consent Agenda Item 9.A. (AI-76783) – Purchasing Department**

The department approval of the specifications, the procurement packet, and legal counsel's review and approval of the procurement packet are not attached. We recommend that these items be attached prior to Commissioners Court approval.

**Consent Agenda Item 9.X. (AI-76789) – Purchasing Department**

The agenda caption references the incorrect contract number. The correct contract number is C-19-123-07-30. We recommend that the correct contract number be stated for the record prior to Commissioners Court approval.
