Throughout the month of July, L&G Engineering staff...

- Mr. Behrooz Badiozzamani, P.E. has been coordinating with Mr. Armando Garza since the request to move several FY2020 ROW fund from FY2020 to FY 2021 is pending, and policy committee approved the new TIP(new TIP IS FY2021, 2022, 2023, 2024) (the current TIP is FY2019,2020,2021, 2022), several accelerated strategies are being implemented to ask for the release of ROW from TXDOT, on the Eldora, Nolana and both Cesar Chavez projects prior to the implementation of the new TIP(SEP, or OCT 2020). Also preliminary requests are being worked on to move the ROW funds into the new TIP as soon as the amendments for the NEW TIP are requested.
- L&G engineering staff have continued to verify the accuracy of all related information regarding the allocated cat7 Funds, for both HIDALGO COUNTY AND THE CITY OF MISSION projects in the new TIP, as well as the updates to the MTP. Discrepancies found were communicated to the MPO staff and were corrected prior to TIP approval. Any additional modifications found will be communicated to the RGVMPPO staff on the new TIP amendments.
