I want to thank you and your organization for the gracious offer of hand sanitizer for our County. We estimate that today there are 3,300 employees in our organization. Additionally, Hidalgo County is home to an estimated 1 million residents. As you may be aware, our area has been hit particularly hard by COVID-19. As of August 13, 2020, Hidalgo County has an estimated 21,275 positive tests.
