Once we have this statement we can proceed with the approval through Commissioners' Court to advertise and then the advertisement on the items.

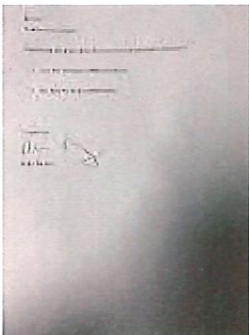
