Yes, the apparel is an allowable expense as long as the cost per unit is below \$5. This is specific to items that are being used as incentives or to be given to participants. If the clothing includes things like uniform shirts for the CHWs, they would go under a different line item and would not need to follow the \$5 unit cost requirement.
