We conducted a limited scope review of the Regular and Consent Agendas for September 22, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 9.A (AI-77463) – Purchasing Department

Legal counsel's review and approval of the agreement is not attached. We recommend that legal counsel's approval of the agreement be attached prior to Commissioners Court approval.

Regular Agenda Item 10.E. (AI-77478) – Human Resources Department for Tax Office

Funding is undetermined pursuant to the Fiscal Note. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 16.B (AI-77446)- Precinct 1

The Federal Assistance Standard Form 424 attached to the agenda is not completed. The completed form was provided to the County Auditor's Office this morning; however, there is insufficient time for our review. We recommend that the completed Federal Assistance Standard Form 424 be attached to the agenda prior to Commissioners Court approval and that Court take action to have the Judge sign the Federal Assistance Standard Form 424 after the County Auditor's Office completes their review.

Regular Agenda Item 19.A.6 (AI-77465) – Purchasing Department

Pursuant to the Purchasing Department, no action will be recommended. The agenda item will be placed on the next agenda.
