Regular Agenda Item 18.A.6.A (AI-77527) – Purchasing Department

Legal counsel's review and approval of the RFQ packet is not attached. We recommend that legal counsel's approval of the RFQ packet be attached prior to Commissioners Court approval.

Regular Agenda Item 18.D.1 (AI-77549) – Purchasing Department

There are insufficient funds in the proper account to cover the contract. We recommend that sufficient funding be in place prior to Commissioners Court approval.

Regular Agenda Item 20.A.1 (AI-77577) – Executive Office

The Interlocal Cooperation Agreements(ICA's), Memoranda of Understanding, and sam.gov verifications are not attached. We recommend that these items be attached prior to Commissioners Court approval.
