Thank you for providing follow-up information. Based on information provided, please find attached drafts of Exhibit A and Exhibit B with our recommended modifications for your review. As discussed, Exhibit A has been modified to address the additional (Edinburg) OPIS Rack Price Pad site or one most advantageous to the County.

Recommend that Exhibit B revert to only having one column for calculation but include areas to indicate the least expensive Pad. Please remove the last two columns. Additionally, instruction included at beginning in addition to the previously advised language that form should be filled out in its entirety.

Thank you for forwarding the attachment. It appears Drainage District's RFB is also limited to the Harlingen pad site. As previously discussed, it is recommended to verify if the "pad sites" listed on the provided OPIS fuel guide sheet are the only pad sites available to choose from or are they specific to the current vendor only.
