Dr. Farley became a doctor in 1994 once she received her medical degree from the University of Texas Health Science Center in San Antonio, Texas where she also completed her residency and forensic fellowship; and

Over the course of her 26 year career Dr. Farley led countless lectures, seminars, and presentations on the diverse studies of Forensic pathology. She has acquired numerous accolades, honors and awards for her many accomplishments and contributions to her profession while having many articles published in medical journals; and

from September 2009 to September 2010, Dr. Farley was appointed to the Texas Forensic Science Commission by then-Governor Rick Perry; and

while also serving on the Board of Editors for the American Journal of Forensic Medicine and Pathology, Dr. Farley participated and served on several National Association of Medical Examiners Ad hoc Committees, the Hidalgo County Child Fatality Review, Mass Disaster Planning Committee, and the Infection Control Committee; and
