Re: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for October 13, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Regular Agenda Item 6.B. (AI-77811) – County Judge's Office

The agenda item does not indicate what action is being requested or if there is a fiscal impact associated with the action requested. In addition, no supporting documentation is attached. We recommend that the purpose of the agenda item and any fiscal impact be disclosed in the Background section and any documents that may support the request be attached prior to Commissioners Court approval.

Regular Agenda Item 9.B. (AI-77769) – Human Resources

The Personnel Adjustment Request (PAR) form is not approved/signed by DBM and the Reclassification Committee Recommendation Form is not signed/approved by the Treasurer and DBM. In addition, the salary allocation on the agenda caption does not agree to the salary allocation on the attached PAR. We recommend that correct and fully executed PAR and Reclassification forms be attached prior to Commissioners Court approval.

Regular Agenda Item 16.A. (AI-77770) – Precinct No. 1

We recommend that, if approved, these General Land Office (GLO) awards be administered by the Urban County Program as is the case with all other awards from the GLO.

Regular Agenda Item 19.B. (AI-77757) – Budget & Management

The Exhibit A is not attached. We recommend that Exhibit A be attached prior to Commissioners Court approval.

Regular Agenda Item 20.A.3 (AI-77760) – Purchasing Department

Legal counsel's review of the Lamar contract is not attached. In addition, the Certificates of Interested Parties (Form 1295) and sam.gov verification for all four listed vendors are not attached. We recommend that these items be attached prior to Commissioners Court approval.

Regular Agenda Item 20.B.1 (AI-77820) – Purchasing Department

The agenda item briefing, proposal/quote from Holt-Cat, and sam.gov verification are not attached. We recommend that these items be attached prior to Commissioners Court approval.

In addition, funding has not been identified. We recommend that these items be attached and funding be identified prior to Commissioners Court approval.


