**FIRST AMENDMENT TO SERVICE CONTRACT
#C-18-140-07-03**

This **AMENDMENT** to **CONTRACT** is made this _____ day of _____, **2020**, by and between and the **COUNTY OF HIDALGO, TEXAS** hereinafter referred to as (“County”) and **ELIGIBILITY TRACKING CALCULATORS, LLC** (the “**CONSULTANT**”).

WHEREAS, **COUNTY** and **CONSULTANT** entered into a Contract for Services on July 3, 2018 (the “**CONTRACT**”) in which **CONSULTANT** agreed to provide services for the purpose of “Healthcare Reform Employee Tracking & Reporting Consultant” (the “**SERVICES**”) on an as needed basis for **COUNTY**;

WHEREAS, **CONSULTANT** advised **COUNTY** that it will be dissolving **Eligibility Tracking Calculators, LLC** and the work performed by **Eligibility Tracking Calculators, LLC** would then be performed by **ETC Lite, LLC**, also owned by **CONSULTANT**;

WHEREAS **CONSULTANT** advises **COUNTY** that **ETC Lite, LLC** is a company in good standing organized under the laws of the State of Texas.

WHEREAS, the **COUNTY** and **CONSULTANT**, due to certain circumstance, require further clarification of the services to be provided by **CONSULTANT** and hereby requires the amendment of the **CONTRACT**; and

WHEREAS, the parties have agreed to amend the **CONTRACT** as hereinafter provided;

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, **COUNTY** and **CONSULTANT** hereby agree to the following amendment to the Contract:

1. **CONSULTANT’S** name “**Eligibility Tracking Calculators, LLC**” shall be replaced wherever it appears in the **CONTRACT** with the name “**ETC Lite, LLC**” effective upon the transfer as described above; and
2. Effective January 1, 2021, **CONSULTANT** shall no longer provide Eligibility Tracking Services, and Section 1 of Exhibit “B”- entitled “Eligibility Tracking – Consulting Fee” shall be deleted in its entirety; and
3. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and **CONSULTANT** and **COUNTY** ratify and confirm the terms and provisions of the Contract as amended.
