Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for October 20, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Regular Agenda Item 16.A.1 (AI-77882) – Purchasing Department

The Certificate of Interested Parties (Form 1295) for Telemundo is not attached. We recommend that Form 1295 be attached prior to Commissioners Court approval.

Regular Agenda Item 16.A.3 (AI-77803) – Purchasing Department

Exhibit A includes a vehicle purchased with grant funds (Local Border Security Program). Assets purchased with grant funds need grantor approval prior to disposition. We recommend that the grantor's approval be attached prior to Commissioners Court approval.

Regular Agenda Item 16.A.4 (AI-77856) – Purchasing Department

The department approval of the specifications is not attached. We recommend that the department approval be attached prior to Commissioners Court approval.

Regular Agenda Item 16.E.1 (AI-77905) – Purchasing Department

The funding source for the purchase is not disclosed on the Fiscal Impact section or displayed on the referenced requisition. We recommend that the funding source be disclosed prior to Commissioners Court approval.

Regular Agenda Item 17.C. (AI-77835) – Executive Office

Legal counsel's review and approval of the fee schedule is not attached. We recommend that legal counsel's approval of the fee schedule be attached prior to Commissioners Court approval.
