**SECOND (2<sup>ND</sup>) AMENDMENT TO  
CONTRACT #C-20-122-04-07**

This **AMENDMENT** to the **CONTRACT** is made this 10<sup>TH</sup> day of NOVEMBER 2020 by and between **HIDALGO COUNTY, TEXAS** (the "COUNTY") and **ABSOLUTE BUSINESS CONSULTING GROUP** ("Consultant").

**WHEREAS**, COUNTY and Absolute Business Consulting Group entered into a Consulting Agreement on April 07, 2020, for General Consulting Services, Graphic Design and Creative Development Services, and;

**WHEREAS**, the parties desire to amend the Contract as hereinafter provided.

**WHEREAS**, due to ongoing COVID 19 public health emergency, the County requires the need to have the Consultant provide additional services, and thus, the Parties now desire to amend the Contract as hereinafter provided.

**NOW THEREFORE**, for and in consideration of the terms and provisions set forth herein, for good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, COUNTY and Absolute Business Consulting Group hereby agree to the following amendment to the Contract

1. The current Section 1 of the Contract shall be amended by replacing it with the following:

*"Consultant agrees to provide the County with ongoing, as **needed General Consulting Services, Graphic Design, Creative Development and Video Production Services**. As consideration for the services to be rendered by the Consultant, as identified in Exhibit "A", attached hereto, County agrees to pay Consultant the fees as outlined in Exhibit "B" Fee Schedule, which is attached to and made a part of this contract for General Consulting, Graphic Design, Creative Development and Video Production Services. Payments to the Consultant for Services shall be payable against written invoice submitted by Consultant on or before the 30<sup>th</sup> day.*

2. Exhibit B shall be modified to reflect the changes to the provision indicated in number 1.

3. Any additional costs shall be approved in writing by the County prior to execution.

4. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect. COUNTY and ABSOLUTE BUSINESS CONSULTING GROUP ratify and confirm the terms and provisions of the CONTRACT as amended herein.
