1. The awarded vendor shall haul road materials (i.e. CRUSHED CALICHE & PIT-RUN CALICHE) from supply vendor "PIT" locations that are currently holding the contract for road material bids. Supply vendor(s) listed below are presently on Contract to provide road materials from the listed location(s); however, due to contract expiration or other circumstance, supply vendor(s) may change during the term of this bid/agreement. Awarded vendor(s) will be advised.
