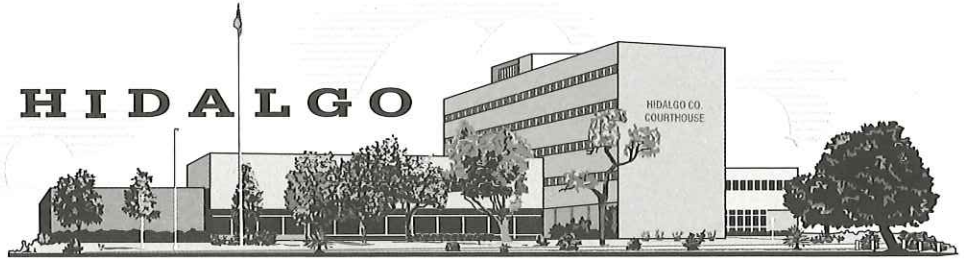

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for November 17, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 9.A. (AI-78174) – Purchasing Department

The contract number for Galls, LLC should be C-17-122b-11-28. We recommend that the correct contract number be stated for the record prior to Commissioners Court approval.

Consent Agenda Item 9.J. (AI-78247) – Purchasing Department

The statute referenced on item 2 should be 263.152(a) (1) and/or (3). We recommend that the correct statute be stated for the record prior to Commissioners Court approval.

Regular Agenda Item 6.A. (AI-78309) – County Judge's Office

The Certification of Formation and Bylaws were previously approved on September 5, 2017 (AI-61465). In addition, legal counsel's review and approval of the Resolution, Certificate of Formation, and Bylaws is not attached. We recommend that legal counsel's review and approval be attached prior to Commissioners Court approval.

Regular Agenda Item 14.A.1 (AI-78306) – Purchasing Department

Pursuant to question 58 of the Treasury's CRF FAQs (October 19, 2020), in the context of acquisitions of equipment, the acquisition itself must be necessary. In particular, a government must (i) determine that it is not able to meet the need arising from the public health emergency in a cost-effective manner by leasing equipment and (ii) maintain documentation to support this determination. Documentation of the determination is not attached. We recommend that the determination be attached prior to Commissioners Court approval.

In addition, pursuant to the Treasury CRF Guidance (September 2, 2020), payment from the CRF may only be used to cover costs that were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020 (the "covered period"). Therefore, it is necessary that performance or delivery take place during the covered period. Some of the options listed on the agenda indicate that the delivery of the trucks/equipment will not occur within the performance period. We recommend that alternate funding be identified if an option is selected for which delivery will not take place by December 30, 2020.

Also, the Certificates of Interested Parties (Form 1295) for Big D Tractor Company and Rush Truck Center were not attached. We recommend that Forms 1295 be attached prior to Commissioners Court approval.

Exhibits A, B, and C referenced on Work Authorization No. 2 are not attached. We recommend that the Exhibits be attached prior to Commissioners Court approval.
- Regular Agenda Item 14.D.1 (AI-78304) – Purchasing Department for Precinct No. 4  
The Agreement and legal counsel’s review and approval of the Agreement are not attached. We recommend that these items be attached prior to Commissioners Court approval.
- Regular Agenda Item 14.E.1 (AI-78244) – Purchasing Department for IT Department  
Form 213 is not attached. In addition, the caption should have also included quote Q10282020MM. We recommend that Form 213 be attached and that quote Q10282020MM be stated as an addition prior to Commissioners Court approval.
- Regular Agenda Item 14.F.1 (AI-75863) – Purchasing Department for Health & Human Services Dept.  
Pursuant to the Treasury CRF Guidance (September 2, 2020), payment from the CRF may only be used to cover costs that were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020 (the “covered period”). Therefore, it is necessary that performance or delivery take place during the covered period. The quotes/proposals did not indicate the date of performance or delivery. We recommend that alternate funding be identified for items for which delivery will not take place by December 30, 2020.
- In addition, Forms 213 for Phase 1 requisitions are not attached. We recommend that Forms 213 be attached prior to Commissioners Court approval.
- Regular Agenda Item 14.G.1 (AI-78260) – Purchasing Department for Facilities Management  
Pursuant to the Treasury CRF Guidance (September 2, 2020), payment from the CRF may only be used to cover costs that were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020 (the “covered period”). Therefore, it is necessary that performance or delivery take place during the covered period. The quotes/proposal indicate that performance or delivery will take place 72 days after receipt of the PO by the vendor. We recommend that alternate funding be identified since performance/delivery will not take place by December 30, 2020.
- In addition, Form 213 is not attached. We recommend that Form 213 be attached prior to Commissioners Court approval.
- Regular Agenda Item 14.H.1 (AI-78311) – Purchasing Department for Sheriff’s Office  
Funding for Work Authorization #3 is not identified. We recommend that funding be identified prior to Commissioners Court approval.
- Regular Agenda Item 14.H.3 (AI-78248) – Purchasing Department for Sheriff’s Office  
The current insurance for Dr. Ivan Melendez is not attached. We recommend that the insurance be attached prior to Commissioners Court approval.
- Regular Agenda Item 16.A.1. a & b (AI-78310) – Executive Office  
The MOU’s with ESD No. 2 and Ambulance Companies, legal counsel’s approval of the MOU’s, sam.gov verification, and Certificates of Interested Parties (Form 1295) are not attached. We recommend that these items be attached prior to Commissioners Court approval.
