**FIRST AMENDMENT TO SERVICE CONTRACT
(C-19-281-11-19)**

This **AMENDMENT** to the service contract (“Contract”) is made this 24th day of **November, 2020**, by and between the **County of Hidalgo, Texas** (“County”) and **Margarita Peña dba Delta Specialties Signs & Supply** (“Company”).

WHEREAS, on November 19, 2019, the County and **Martin Peña dba Delta Specialties Signs & Supply** entered into a Contract, in which **Martin Peña dba Delta Specialties Signs & Supply** agreed to provide “Traffic Road Signs & Misc. Items” to the County.

WHEREAS, on or about November 2, 2020, the County advised Company of its election to exercise the one year extension of the Contract.

WHEREAS, in response, on or about November 10, 2020, Ms. Margarita Pena notified County of the untimely death of her husband Mr. Martin Peña and her intent to continue the business.

WHEREAS. Ms. Peña provided an Assumed Name Certificate filed with the Hidalgo County Clerk on or about August 11, 2020, reflecting Ms. Peña as the owner of Delta Specialty Signs & Supplies. (See Attached **Exhibit A**).

WHEREAS. Ms. Peña also provided to the County additional necessary Company business documents (i.e., EIN, DUNS, SAM, HUB & CMBL, etc.) reflecting the name change;

WHEREAS, Martin Peña’s wife, Margarita Peña, can be described as an heir, executor, administrator, legal representative, successor, and or an assign; and

WHEREAS, as authorized by the terms of the Agreement, this Contract shall be binding upon and inure to the benefit of and be enforceable by the parties hereto and their

heirs, executors, administrators, legal representatives, successors, and assigns where permitted by the Contract; and

WHEREAS, as authorized by the terms of the Contract, any Amendments will be effective if made in writing and approved by the Parties; and

WHEREAS, the parties desire to amend the Contract as hereinafter provided.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Company hereby agree to the following amendment to the Contract:

1. **Margarita Peña dba Delta Specialty Sign & Supply** is hereby the name of the Company and is hereby substituted throughout the Contract in lieu of the name of Martin Peña dba Delta Specialty Sign & Supply;

Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect and Company and County ratify and confirm the terms and provisions of the Contract as amended.

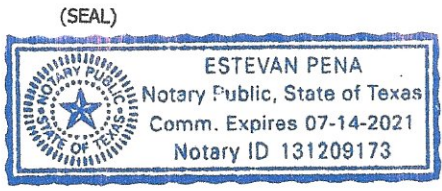


