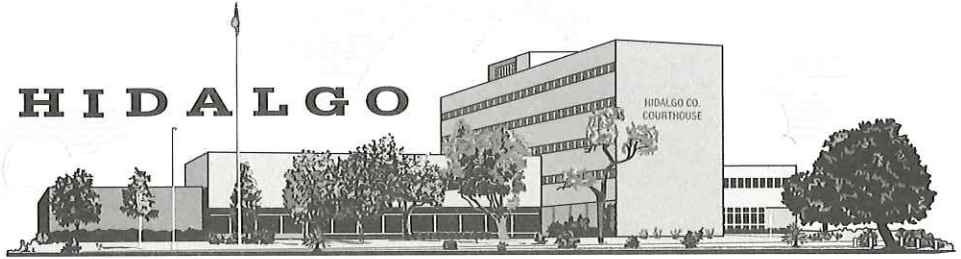

We conducted a limited scope review of the Regular and Consent Agendas for November 24, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 3.T. (AI-78360) – Intradepartmental transfers (HIDTA CCP 59)

The agenda caption should state HIDTA CCP 59 instead of DA FED SHRG-CCP 59. We recommend that the correct department be stated for the record prior to Commissioners Court approval.

Regular Agenda Item 11.A. (AI-78405)- Emergency Management

The department will request no action on this item.

Regular Agenda Item 17.a, b & c (AI-78366) – Executive Office

The MOU's with RGV Livestock Show, municipalities, and hospitals, legal counsel's approval of the MOU's with the municipalities and hospitals, sam.gov verification, and Certificates of Interested Parties (Form 1295) are not attached. We recommend that these items be attached prior to Commissioners Court approval.
