I am not sure what type of services are being provided, but there are a couple of concerns with the terms and conditions, as noted below:

Paragraph 3. - the agreement requires the payment of attorneys fees in the event necessary to collect late payments; we would recommend including language adding "to the extent permitted under the law" to this provision;

Paragraph 10 - the term of the agreement is unclear (refers back to the order); recommend noting it is for a one year term with specific end date;

Paragraph 11.5 - noted jurisdiction over the governance of this agreement is the State of Delaware and subjects the County to the jurisdiction of the courts of the state of Delaware; County cannot agree to same; therefore, recommend it be changed to Texas.
