Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for December 1, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Regular Agenda Item 8.E. (AI-78491) – Human Resources

The attached Personnel Adjustment Request (PAR) form and Fiscal Note include a \$2,000 auto allowance which is not noted on the agenda caption. In addition, the PAR is not signed/approved by HR or DBM and, pursuant to the Fiscal Note, there is no funding identified for the new position. We recommend that the \$2,000 auto allowance be disclosed for the record prior to Commissioners Court approval. In addition, we recommend that the fully executed PAR form be attached and funding be identified prior to Commissioners Court approval.

Regular Agenda Item 12.A.1 (AI-78518) – Purchasing Department

Form 213, legal counsel's approval of the contracts, sam.gov verifications, and Certificates of Interested Parties (Form 1295) are not attached. We recommend that these items be attached prior to Commissioners Court approval.

Regular Agenda Item 12.A.2.B (AI-78481) – Purchasing Department

Legal counsel's approval of TCAP's Professional Services Agreement (Exhibit A) and Gexa Energy's Commercial Electricity Service Agreement (Exhibit B) referenced on the Resolution is not attached. Purchasing has advised that no action will be recommended on this item.

Regular Agenda Item 12.A.4 (AI-78461) – Purchasing Department

The Certificate of Interested Parties (Form 1295) is not attached. We recommend that Form 1295 be attached prior to Commissioners Court approval.

Regular Agenda Item 12.A.5 (AI-78474) – Purchasing Department

The bid page is not attached. We recommend that the bid page be attached prior to Commissioners Court approval.
