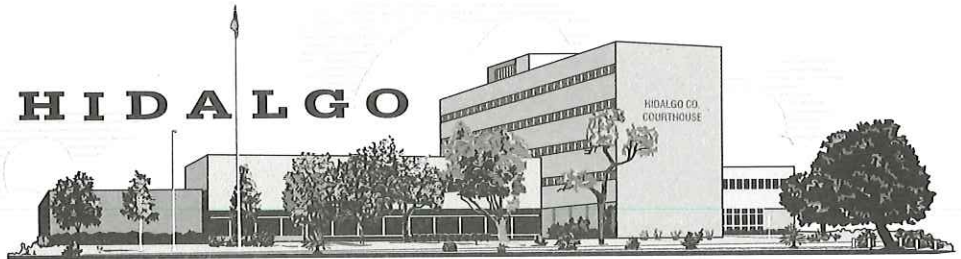

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for December 15, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 9.D. (AI-78701) – Purchasing Department

This agenda item is requesting an exemption from competitive bidding requirements. We recommend that this item be pulled for discussion prior to Commissioners Court approval.

Regular Agenda Item 8.A. (AI-78667) – HIDTA

The MOU's need to be revised to remove any references to Equitable Sharing Guidelines. The DA's Office has advised that no action will be requested on this item.

Regular Agenda Item 14.B. (AI-78617) – Health Care Funding District

The certification of revenues and appropriation for the IGT are pending receipt of HHSC instructions.

Regular Agenda Item 18.C.1. (AI-78671) – Purchasing Department

The Certificates of Interested Parties (Form 1295) and Form 213 for ONSITE and Visionality are not attached. We recommend that these items be attached prior to Commissioners Court approval.

Regular Agenda Item 18.G.1 (AI-78658) – Purchasing Department for Health & Human Services Dept.

The revised Exhibit D is not attached. We recommend that the revised Exhibit D be attached prior to Commissioners Court approval.

Regular Agenda Item 18.I.2 (AI-78271) – Purchasing Department for Sheriff's Office

Based on the FMV of the equipment and the monthly payment amount, the lease interest rate exceeds the maximum net effective interest rate pursuant to Local Government Code Sec. 271.005(c) and Government Code Sec. 1204.006. The Purchasing Department has advised that no action will be requested on this item.
