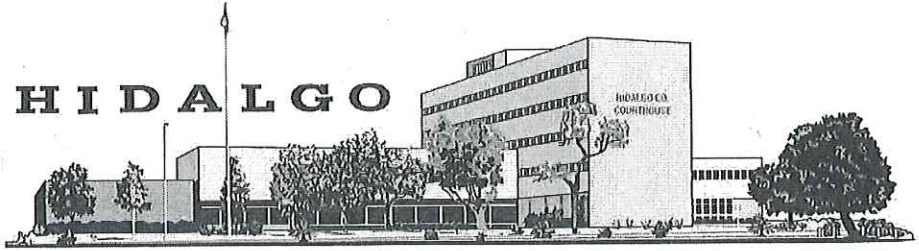

We conducted a limited scope review of the Regular and Consent Agendas for December 22, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Regular Agenda Item 12.C. (AI-78267) – Human Resources

Pursuant to the Fiscal Note, there is no funding identified for the new positions. We recommend that the funding be identified prior to Commissioners Court approval.

Regular Agenda Item 12.D. (AI-78822) – Human Resources

Pursuant to the Fiscal Note, there is no funding identified for the increase in auto allowance. We recommend that the funding be identified prior to Commissioners Court approval.


Regular Agenda Item 18.H.1 (AI-78668) – Purchasing Department for Facilities Management

The agreement, legal counsel's review and approval of the agreement, and the current ACORD Certificate of Liability Insurance were not attached. We recommend that the agreement, legal counsel's approval, and the ACORD Certificate be attached prior to Commissioners Court approval.

Regular Agenda Item 20.A.1.a (AI-78798) – Executive Office
