Good afternoon Mr. Cantu,

On June, 2020 you reviewed and approved the above referenced contract for the Purchase of Electronic Medical Records (EMR) Software System for the Health and Human Services Department. (COVID-19 related).

Health and Human Services Department (HHSD) at this time need to add an additional software module which gives HHSD direct communications to the State of Texas Immunizations Registry and would make the immunizations program run smoother the cost for this Service is \$5,000.00 for implementation, \$2,400.00 yearly for total of \$7,400 for 1st year w/2 additional 1yr renewals @ 2,400.00 per yr.

My question to you is, can the contract be amended to add this service or will I need a whole different contract?

I have attached both the contract and quote for the additional module and await your response to proceed accordingly.
