Attached you will find a copy for your review and revision of an Interlocal Agreement between the City of Donna and Hidalgo County Pct. 1. I have entered most of the information needed for your review but we need to add the following information. The City of Donna will reimburse the County of Hidalgo Pct. 1 for all materials such as the Stripping, SS1 Oil, Pipes, and Hot Mix with the City of Donna's 2021 Urban County Allocation in the total amount of \$63,940.20 (plus the cost of stripping-waiting for the cost estimate from Pct. 1) Please note that I will have the total cost estimate in Exhibit B before the interlocal goes to Commissioner's Court and City of Donna's City Council.
