Following are the concerns I identified in your email below with an answer or clarification for each concern.

#1 states that STC will provide HCSO with the program curriculum – This should have read that the Receiving Party would provide the Performing Party the curriculum. Attached is the corrected MOU.

#3 talks about a Memorandum of Assignment – Attached is the Memorandum of Assignment. Since STC will be reporting these course to the Texas Higher Education Coordinating Board, we will need the trainers' information to be able to report the training. This form only needs to be completed once regardless of how many classes are taught, so we can have all your potential trainers complete the form at the beginning. When we report the course, we will simply list all the trainers that conducted any part of the training.

#13 does not provide for a mutually agreeable time for the observation of instruction – Once the schedule for the course has been set, you can let us know the day and time that would be best for us to conduct the observation. The observation takes between 30 and 60 minutes.

The questions are in regard to the services to be performed. In the Services to be Performed section, #1 states that STC will provide HCSO with the program curriculum. In regard to this service, are we talking about the curriculum that STC wants taught, which is provided by TCOLE, or the curriculum that STC mandates for course credit? #3 talks about a Memorandum of Assignment of which we have no example which could be a concern since we use multiple instructors for the Basic County Corrections Course and at times have to pull an instructor for a different assignment. #13 does not provide for a mutually agreeable time for the observation of instruction. Please advise at your earliest convenience.
