**FIRST AMENDMENT TO
MEMORANDUM OF UNDERSTANDING NO. 2021-195 - Hidalgo County Head Start
Program - School Readiness Partnership Model (SRPM)**

This First Amendment to Memorandum of Understanding No. 2021-195 (the "MOU") is made this 18th day of January, 2021 by and between McAllen Independent School District ("District") and Hidalgo County Head Start Program, a Government Entity ("Contractor") as follows:

WHEREAS, the District entered into Memorandum of Understanding No. 2021-195 dated June 18, 2018; and

WHEREAS, the District and Contractor desire to amend the MOU.
