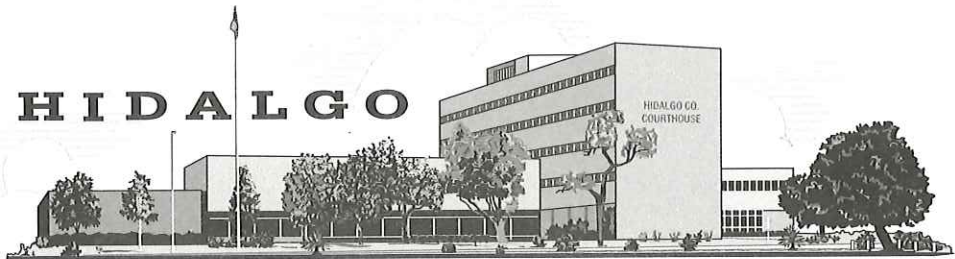

Re: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for February 2, 2021. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 8.D. (AI-79180) – Constable Precinct No. 2

The Affidavit for Membership Dues for 3 of 20 employees are not attached. We recommend that the affidavits be attached prior to Commissioners Court approval.

Consent Agenda Item 10.I. (AI-79354) – Purchasing Department

The agenda caption referenced the wrong application number. The agenda caption should have referenced Application #2. We recommend that the correct application number be stated for the record prior to Commissioners Court approval.

Regular Agenda Item 6.A. (AI-79381) – County Judge's Office

The County is only authorized to waive penalties and interest under certain circumstances specifically enumerated in Section 33.011 of the Tax Code. We recommend that legal counsel's review and approval of the waiver of penalties and interest be obtained prior to Commissioners Court approval.

Regular Agenda Item 13.A. (AI-79294) – Constable Precinct No. 1

The County Auditor's Office review of the FY2020 Equitable Sharing Agreement and Certification Report has not been finalized. The Constable's Office has advised that no action will be requested on this agenda item.

Regular Agenda Item 20.A.2 (AI-79369) – Purchasing Department

The funding source identified for the month-to-month lease does not have sufficient funds to cover the two invoices or any future invoices. We recommend that funding be in place prior to Commissioners Court approval.

Regular Agenda Item 20.C.1 (AI-79319) – Purchasing Department for Sheriff's Office

The funding source was not identified for the lighting retrofit. We recommend that the funding source be identified prior to Commissioners Court approval.
