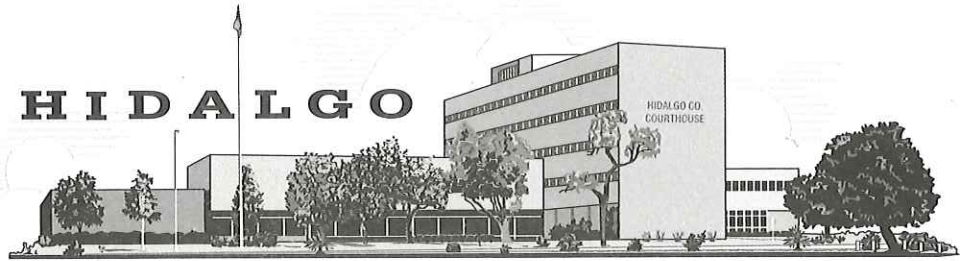

Consent Agenda Item 10.N. (AI-79428) – Purchasing Department for Constable Pct. 4

Funding for the purchase of the vehicle is from the 2019 Operation Stonegarden (OPSG) grant. However, the specific make and model of vehicle requested to be purchased is not allowable under the OPSG grant. The Constable's Office has advised that no action will be requested on this item.
