In order to proceed with approval of **60 Day Extension** for referenced project by **Commissioners Court on March 02, 2021**, the signed notarized "**HB Form 1295**" and "**Extension Notice**" must be received in our office completed **by no later than Wednesday, February 24, 2021 or sooner if possible**. Hidalgo County cannot enter into a contract until Form 1295 is submitted, therefore, failure to timely submit Form 1295 signed, and notarized may result in delay of award.

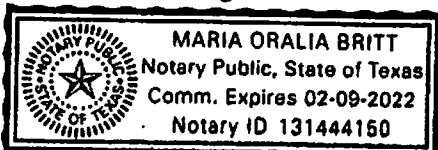
