My name is Captain Jose Vasquez and I am an Administrative Captain at the Hidalgo County Hidalgo County Sheriff's Office.

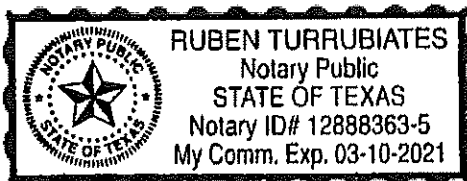

The above is true and correct to the best of my knowledge.


