Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for March 30, 2021. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 3.G. (AI-80107) – 2021 Intradepartmental Transfer: Facilities Management
The transfer is for Facilities Management operations not Facilities Management Countywide. We recommend that the clarification be stated for the record prior to Commissioners Court approval.

Consent Agenda Item 7.E. (AI-80091) – Tax Refund
The amount of the refund is \$12,410.91 not \$18,553.69. We recommend that the clarification be stated for the record prior to Commissioners Court approval.

Regular Agenda Item 8.B.2. (AI-80076) – Constable Pct. 3
The amount requested to appropriate from the LEOSE Fund unassigned fund balance is not correct. The correct amount will be appropriated via a carry-over by the Auditor's Office. We recommend that no action be taken on this item.

Regular Agenda Item 10.B. (AI-80153) – Human Resources
There are insufficient funds available in the account/budget referenced in the Fiscal Impact. We recommend that funding be in place prior to Commissioners Court approval.
