We conducted a limited scope review of the Regular and Consent Agendas for April 6, 2021. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 3.D. (AI-80193) – 2021 Intradepartmental Transfer: Precinct No. 1

The transfer is for Road Maintenance not Administration. We recommend that the clarification be stated for the record prior to Commissioners Court approval.

Consent Agenda Item 7.A. (AI-80196) – Membership Dues: County Treasurer

The incorrect Affidavit for Membership Dues is attached. We recommend that the correct Affidavit be attached prior to Commissioners Court approval.

Regular Agenda Item 18.A. (AI-80261) – Purchasing Department for Precinct No. 2

The agreement, legal counsel's approval of the agreement, Certificate of Interested Parties (Form 1295), and ACORD Certificate of General Liability Insurance are not attached. We recommend that these items be attached prior to Commissioners Court approval.


Regular Agenda Item 18.B.1.A. (AI-80215) – Purchasing Department for Precinct No. 3
